your personal data, provided by you upon completing the contact form, will be processed by our company in compliance with the laws in force and the disclosure obligations to which we have always adhered to, as follows:

Identity and contact details of the data controller

The data controller is the company Lovato spa, with registered office in Gazzolo di Arcole (VR), via Selva 4/A, which you can contact at any time, for any need or request related to the processing of your data, by sending an e-mail to info@lovatospa.com.

What data we process, for what purposes, and the legal basis of the processing

By filling in the contact form, we will collect and process your personal data to review and find your request.

In the cases indicated above, the data processing is legitimate as it is necessary to execute a pre-contractual request of the interested party (see Article 6 paragraph 1 letter b GDPR).

With your consent (which constitutes a condition of lawful processing), we will also process your e-mail address and contact details to send you business communications relating to our products by e-mail.

Possible recipients or categories of recipients of personal data

The personal data referred to above will be processed by the Data Controller by means of persons authorized to process (i.e., persons within their organization); if the data were processed by external suppliers, for the same purposes, the aforementioned will be duly appointed as data supervisors.

The dissemination of your personal data is not anticipated.

Data retention policy

In accordance with the principles set out in the GDPR, your data will be stored only for the period necessary for the purposes for which they are collected and processed, and, therefore, to process your request.

The data necessary to send commercial and promotional communications will be stored and processed until you have revoked your consent.

Your rights concerning your personal data

We remind you that, depending on the specific processing, at any time:

- a) You can ask for access to your personal data, or ask that these data be corrected or cancelled, or that your data processing be limited; furthermore, you have the right to data portability;
- b) You have the right to withdraw consent to the processing, and the right to lodge a complaint with the supervisory authority (Data Protection Authority).

Disclosure of personal data (by law or by contract or to conclude the contract) and the consequences of not providing it

The provision of your personal data is optional, but if you do not provide the data indicated in the contact form, you cannot send your request.

The consent to the processing for sending commercial and promotional communications is optional, and in its absence, you will not receive updates on our products, but can still send the request for contact.
